Magisterial District Courts

Precinct Judge of Elections, Majority and Minority Inspectors

Judge of Elections and Majority and Minority Inspectors will be open positions and available for election in 2025. We encourage Republicans to run for **Judge of Elections** and **Inspector** roles—critical positions ensuring the integrity of our elections.

There are three ways to become a Judge of Elections, Majority or Minority Inspector:

1. File a petition with and appear in Court;
2. Get appointed via Emergency Resolution days before each election (subject to Voter Services' discretion and, if appointed, only serve for that one election); or
3. Run on the ticket in 2025 and get elected. *****THIS IS THE BEST WAY***** and guarantees service for a four-year term beginning in 2026.

Candidates for Judge of Election, Majority Inspector, and Minority Inspector in each precinct must get their names on the ballot in the 2025 Primary.

Additionally, some townships may have opportunities on **Planning Commissions**, **Zoning Boards**, and other advisory groups that significantly impact our communities.
